EFFECTS OF OVEREXPOSURE:

Prolonged or repeated liquid contact with skin will dry and defat skin, leading to irritation or dermatitis. Eye irritant. Effects of ingestion may include headache, drowsiness, nausea, fatigue, pneumonitis, pulmonary edema.

EMERGENCY AND FIRST AID PROCEDURES:

IF IN EYES: Immediately flush eyes with clear water for at least 15 minutes, occasionally lifting lower and upper lids. Get medical attention as soon as possible.

IF ON SKIN: Wash with soap and large quantities of water. Seek medical attention if irritation from contact persists.

IF SWALLOWED: Do not induce vomiting. Get medical attention immediately.

IF INHALED: If overcome by high concentrations of vapor, remove from exposure to fresh air. If breathing is irregular or has stopped, perform artificial respiration. Administer oxygen if available. Get medical attention immediately.

SPILLS OR LEAK PROCEDURE - SECTION VI

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED:

Shut off and eliminate all ignition sources. Keep people away. Recover free product. Add sand, earth or other absorbent material to spill area. Minimize breathing of vapors. Minimize skin contact. Ventilate confined spaces. Open all windows and doors. Keep product out of sewers and waterways. Continue to observe precautions for combustible vapors from absorbed material.

WASTE DISPOSAL METHODS:

Contaminated absorbent may be deposited in sanitary landfill in accordance with local, state and federal regulations.

SPECIAL PROTECTION - SECTION VII

VENTILATION TYPE: General mechanical ventilation may be sufficient to keep product vapor concentrations within TLV.
